With reference to the discussion above, I beg to furnish the status of Amar Dokan in Nagaon Sadar Sub-Division, Kaliabor and Hojai Sub-Division for favour of your kind information and necessary action -

**(1) Nagaon Sadar Sub- Division:** - At present 26 Nos of FP Shops in 26 Wards of Nagaon Town are functioning as Amar Dokan since September'2011. In addition, Nagaon Wholesale Consumer Co-Operative Store's is conducting Mobile Amar Dokan in festive occasion (Photographs of the Mobile Amar Dokan are enclosed). Consumers' response to Mobile Amar Dokan is very encouraging. The following Open Market items are being sold through Amar Dokan at a reasonable rate of price below prevailing market price at least by Rs. 2.00 per Kg.

- (i) Masur Dal.
- (ii) Mustard Oil.
- (iii) Atta
- (iv) Onion
- (v) Potato
- (vi) Moong Dal
- (vii) Rice

**2. Hojai Sub-Division** :- It is reported by the Asstt. Director, Hojai that at present 15 Nos of FP Shops are operating as Amar Dokan at Hojai Town. Amar Dokan is being inaugurated at Lanka, Doboka and Lumding of Hojai Sub-Division shortly.

**3. Kaliabor Sub-Division:**- it is reported by Supdt., FCS & CA, Kaliabor, that only 3 Amar Dokan are functioning in the sub-division. Two Amar Dokan in the Duar - Bagori GPSS area and one at Bholaguri Somobai Somity Area. There is proposal to open another 44 Nos Amar Dokan in Kaliabor Sub-Division at an early date.

It is observed that operations of Mobile Amar Dokan in Festive season are very effective in keeping price line under control. Placement of a mini truck preferably TATA Mobile Truck under the disposal of DDS, Nagaon will facilitate functioning of Mobile Amar Dokan at regular basis in the sub-division.

The Govt. may kindly be moved for placement of a mini truck in Nagaon Sadar Sub-Division to make Mobile Amar Dokan a success.
